

## Terms and Conditions of Entry for the Australian Medicines Handbook Competition

1. Information on how to enter and prize details form part of these conditions. Entry into this Promotion is deemed acceptance of these terms and conditions of entry.
2. The promoter is the Pharmacy Guild of Australia ABN 87 076 197 623 of 132 Leichhardt Street, Spring Hill QLD 4000 (**Promoter**).
3. The Promotion will be open from 9:00 am [AEST] on Friday 30 June 2023 and will continue until 5:00pm [AEST] on Friday 15 December 2023 (**Promotion Period**).
4. Entry is open to all Australian residents aged 17 years and over other than management, employees or contractors of the Promoter and other agencies, firms or companies associated with the Promotion (including suppliers of prizes), and their immediate families (**Eligible Entrants**).
